Transfer between Bozeman and Big Sky - This is included in the package, and it is 55 miles. If you choose to do your own air and transfer (deduct \$350), factor in your transfer cost.

Groceries - We will stop at a grocery/liquor store on the way to Big Sky, subject to change or cancellation prior to trip.

Lift Tickets: Adult 5-day included in package; 6th day add \$120. Senior (70+) 5-day deduct \$40; Senior 6-day add \$70 For "No lift ticket", deduct \$570 from package price. See below for alternate lift options.
